Rates (Prices)


All quoted rates are expressed and payable in Rand (ZAR).

Payments

To secure your booking, we require a deposit.

This will be 100% for a single night 's stay and 50% per person per night for longer stays.

All deposits can be paid through the secure online payment page of PayBridge.

Alternatively, inland South African payments can be made via EFT (electronic funds transfer) into our FNB cheque account, free of bank charges. Please use your name and reference number as payment reference so that we can match the payments.

The remaining balance should be settled on the day of arrival; this may be in cash or by credit card.

Any additional expenses incurred during your stay may be settled in cash or by credit card on the day of departure. A 4% credit card payment fee is added when paying these expenses by credit card.

Accepted credit cards are Visa and MasterCard.

Cancellation Policy

Should you, for whatever reason, cancel your confirmed booking, the following cancellation (forfeit) fees are applied on the deposited amount :

- "no show" : forfeit 100%
- less than 30 days before arrival date : forfeit 100%
- less than 60 days before arrival date : forfeit 75%
- more than 60 days before the arrival date : forfeit 50%

Banking costs and an admin fee of R500 will be deducted from all refunded amounts.

In case of premature departure the remaining balance (total booking less deposit) is to be paid in full.

Applicable laws

On the day of check-in you will be asked to fill out a registration form and supply proof of identity. This is in accordance with the Immigration Act 13 of 2002 (the "Act") as amended on 26 May 2014. Section 40(1) of the Act, read together with Regulation 36, states that, inter alia, all hotels, motels, B&Bs and guest houses must keep a register containing details of **all persons** who are provided with lodging or sleeping accommodation. The Register must, in respect of a lodger, contain:

1. his or her full names and surname;
2. a **copy** of his or her identification document or passport;
3. his or her residence status in the Republic; and
4. his or her normal residential address.
